Investment Highlights:

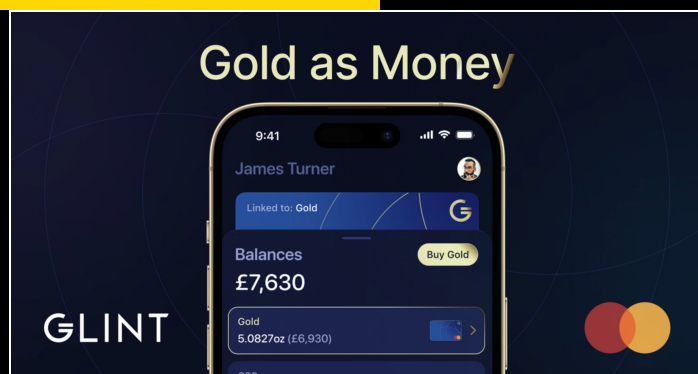
Our featured company, [Glint](#), secured investment from a UHN USA Investor after presenting at the Summer Conference.
